# Water/ Sewer Committee Update:

We had our voices heard with Representative Finstad and participated in a Teamview meeting with Senator Webber this past week. Our district representative Marj Fogelson is introducing a bonding bill asking for 16.2 million dollars to go towards our pond project.

# Public Works Report:

Discussion on the trash pump bids. The one from DSG is turnkey and ready to go. The bid from Beemer's would require additional hoses. Discussion on Ryan to take his class D water test on June 25. Jason passed his class C water test. This makes him 100% licensed to run our water plant. Need the Wacker pump at the waste plant to be rebuilt. Discussion on the service line on Birch St. A new service line was put in and connected to our system. Would like to have Rosberg's cap the old line at the street. Discussion also took place regarding electrical work in the fire hall for the new heaters. We had to have Jetter Clean here to clean out some build up between the detention tank and the filter. At sometime we will need to replace the 45degree pipes. Motion made by Council Member Bradford Flohrs, seconded by Council Member Justin Lubben and motion to approve purchase of 6" trash pump from DSG for \$8223.00. 5-0 Motion made by Council Member Justin Lubben, seconded by Council Member Ronald Shade and motion to approve Rayan Geistfeld to test for class D water test on June 25. 5-0 Motion made by Council Member Brian Krumwiede, seconded by Council Member Ronald Shade and motion to approve Rosberg's to cap Birch St E old sewer connection at the street for \$800. 5-0 Mayor Kuehl abstaining. Discussion on electrical bids for heaters at the fire hall. Motion made by Council Member Ronald Shade, seconded by Council Member Brian Krumwiede, and motion died for lack of unanimous vote 2-2 N: Justin Lubben, **Bradford Flohrs** Council tabled

# Police Report:

DARE program is going well. Discussion on I Crime Fighter. It costs \$700 a year and proves the service of pictures taken during an investigation can be sent directly to the county attorney secure. Waiting for the new tazer to arrive. Looking into having the Sheriff's department for dedicated coverage when Chief is not on duty for PTO.

## Clerk Report:

The farmers market will start the first week of June and be on Wednesday this year. Included with the report is the letter from the attorney about public buildings and email from the insurance company. Council members are not employees of the city and not covered by work comp insurance and need a city staff member with them if they want to go into areas of buildings that are not open to the public. Clerk will send out the work form to fill out if you have any maintenance that needs to be done. Discussion on the Berkley Bond at Edward Jones. Motion made by Council Member Bradford Flohrs, seconded by Council Member Ronald Shadee, and motion to approve cashing out Berkley Bond with Edward Jones, transfer to a CD at local bank with highest interest rate. 5-0 One item that came up in the audit is a couple paychecks that were not cashed from 2021. Clerk will begin the process of getting a claim into the Commissioner of Commerce. The 4M account will now be reconciled as a bank account instead of doing journal entries to reconcile it better. Clerk was notified on Friday that our website contract needs to be renewed by April 1st. Discussion on our options of different companies. The new one offers ADA compliance, being able to use our own pictures and a free notification system. Motion made by Council Member Ronald Shade, to stay with current web company. Motion Withdrawn. Further discussion. Motion made by Council Member Bradford Flohrs, seconded by Council Member Justin Lubben, and motion to approve switching to new website company. 5-0 Council Member Shade asking if we can only bill out what Medicare will pay to not have a big write off at the end of the year.
